

Additional information on the processing of personal data

You hereby acknowledge and confirm that you have read and understood the principles of personal data protection set out in the document "DATA PROTECTION INFORMATION for Mobile Staff Applicants and for Mobile Staff according to GDPR". The controller of personal data in connection with the processing of personal data of applicants for humanitarian missions is the Austrian branch of MSF (Médecins Sans Frontières, i.e. Médecins Sans Frontières, Ärzte ohne Grenzen, Taborstrasse 10, 1020 Vienna, hereinafter referred to as "MSF AT").

Certain sub-steps in the recruitment and mission support process are carried out by the Czech branch of MSF (Médecins Sans Frontières in the Czech Republic, o.p.s., IČ: 28476654, with its registered office at Štětkova 1638/18, 140 00 Prague, hereinafter referred to as "MSF CR") as a personal data processor. Giving consent to the processing of personal data

Protection of personal data is our priority. We would like to ask you for your consent to process your personal data for the following purposes. In relation to this processing, the MSF CR is directly the controller of your personal data.

By sharing your data and personal documents in this application, you are granting in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter referred to as the "Regulation"), your consent to MSF CR as a data controller to the processing of personal data provided by you, in particular: name, surname, nationality, address of permanent and temporary residence, date and place of birth, education, previous work experience and language skills, telephone number, e-mail address, for the following processing purposes:

- further recording of the personal data provided by me in the list of persons potentially interested in cooperation with the Czech MSF branch (or another MSF branch) or in going on missions,
- archiving of provided and validated materials.

The above categories of personal data will be stored by the Czech and Austrian branches of Doctors Without Borders on the basis of these consents, which are granted for a period of 2 years. The consents can be withdrawn at any time by sending an email to the MSF CR office (hr.cz@prague.msf.org). Withdrawal of consents does not affect the lawfulness of the processing previously carried out. You acknowledge that your personal data may be transferred to recipients both within and outside the EU, and that the protection of such data is ensured either on the basis of an existing European Commission decision on adequate protection, or on the basis of standard contractual clauses or other means. An up-to-date list of data recipients and further information regarding the transfer of personal data can also be requested at the above contact email address.

By granting these consents, I further acknowledge that I have the following rights in particular in connection with processing:

- the right of access to personal data;
- the right to rectification;
- the right to erasure;
- the right to restriction of processing, if there is a lawful reason to do so;
- the right to data portability;
- the right to object;
- the right to lodge a complaint with the supervisory authority, which is the Office for Personal Data Protection.
